C) Eligibility Criteria: (Submit proof of eligibility criteria)

Legal entity of the bidder

The bid is open to the following:

- i. Companies registered under the Companies Act, 1956.
- ii. Partnership Firms registered in India,
- iii. Societies registered under the Societies registered under the Societies Registartion Act, 1860 or the Indian Trust Act, 1882
- iv. Sole proprietorship firms whose proprietor is a resident in India as per the Income Tax Act, 1961

Turnover & Profitability

- i. The bidder should have an annual turnover of at least Rs. <50 laks> for the three financial years <2008-09, 2009-10, 2010-11>.
- ii. The bidder should also have a positive Profit After Tax for each of the three financial years.

Experience

- i. The bidder should have been in the business for at least three years as on 31.3. 2011
- ii. The bidder should have supplied/installed/ implemented/ developed atleast <3> orders/ contract, value of each of which exceeds Rs. <30 laks> during the last three financial years.

Registration & licenses

The bidder should have the following:

Eligibility criteria for supply of goods:

- ii. The bidder should confirm that the products are fully compatible with

GNU/LINUX distributions as and where applicable. The bidder should ensure that all hardware/ software comply with Free software and open standard as and where applicable.

iii. The bidder should submit valid letter of authorisation from the OEM.

iv. The bidder should undertake to provide support, spares, patches for the next <7 years>
